

## **Privacy Policy 3S FINANCIAL GROUP Sp z o.o**

### ***Definitions***

1. Administrator – 3S FINANCIAL GROUP Sp z o.o., plac Orłąt Lwowskich 20D, 53-605 Wrocław, NIP 8971835846, REGON 366639069.
2. User / Customer - any natural person visiting the Website or using one or several services offered by the Administrator;
3. Website - a website maintained by the Administrator;
4. GDPR - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC;
5. Policy - this privacy policy.

### **Privacy policy.**

The confidentiality of data and the protection of our clients' privacy is a priority for us. Therefore, in the interests of the security of their data and respecting applicable law, 3S FINANCIAL GROUP Sp z o.o. has established a policy setting out rules on how to collect, process and use personal data.

### **Administrators**

The administrator of personal data is 3S FINANCIAL GROUP Sp z o.o., plac Orłąt Lwowskich 20D, 53-605 Wrocław, NIP 8971835846, REGON 366639069 and Trusted Partners, the full list of which can be found in the "Trusted Partners" section.

### **What is personal data?**

Personal data is, according to the GDPR, information about an identified or identifiable natural person. When using our services, such data is e.g. an e-mail address, IP address or your data in your e-mail account or account in another service offered by 3S FINANCIAL GROUP Sp z o.o. Personal data may be saved in cookies or similar technologies (e.g. local storage) installed by the Administrator or Trusted Partners on websites and devices that are used when using its services.

### **The basis and purpose of processing**

**The processing of personal data requires a legal basis. The GDPR provides for several types of such legal grounds for data processing, and in cases of using the Administrator's services, there are, in principle, three of them:**

- 1) pursuant to art. 6 clause 1 lit. b) and lit. c) GDPR to:
  - a) take action - at the request of the data subject or performance of the contract to which the data subject is a party - before concluding the contract;
  - b) fulfill the legal obligation incumbent on the Administrator;

c) to handle complaints;

2) based on the legitimate interest of 3S FINANCIAL GROUP Sp z o.o (art.6 par.1 lit.f) GDPR) in order to:

a) offering and servicing own products or services;

b) pursuing or securing claims of 3S FINANCIAL GROUP Sp z o.o;

c) for analytical and statistical purposes;

d) for marketing purposes of the Administrator and other entities, in particular related to the presentation of behavioral advertising;

3) on the basis of a separate consent (pursuant to art.6 par.1 lit.a) RODO) in order to:

a) providing the customer with information about proposed changes to the Agreement, including the Regulations, about the change of name (company), address or registered office, confirmation of receipt of the complaint and responding to it to the indicated e-mail address;

b) direct marketing of 3S FINANCIAL GROUP Sp z o.o.' own products or services. Direct marketing to whom this document refers in points a) -b) above can be implemented by 3S FINANCIAL GROUP Sp z o.o. by means of electronic communication (e.g. SMS, MMS, e-mail) and telecommunications terminal equipment (e.g. decoder, telephone, tablet ).

Personal data will be processed only if you have one of the legal grounds allowed by the GDPR and only for the purpose adapted to the given basis, as described above.

#### **The scope of personal data processing:**

The data administrator collects and processes:

a) data necessary to place a purchase order, i.e. in particular: name and surname, home address, e-mail address, contact telephone number.

d) authentication and identification information used to register and log in the User: username, e-mail address and password;

e) contact details (telephone number and e-mail address) processed in the case of requests sent from the contact form available on the Website;

f) payment data (e.g. credit card data or payment tokens from external payment service providers, such as tPay, PayU, FDP);

g) payer's identification data (name and surname, address in the case of individual clients and company name, registered office address and tax identification number in the case of corporate clients) used to record payments and issue appropriate proof of sale.

#### **Period of storage of personal data:**

Period for which personal data will be stored:

1) personal data processed in order to conclude or perform the contract and fulfill the Administrator's legal obligation will be stored for the duration of the contract, and after its expiry for the period necessary for:

a) after-sales customer service;

b) securing or pursuing claims due to 3S FINANCIAL GROUP Sp z o.o.;

c) fulfilling the Administrator's legal obligation;

2) personal data processed for the purposes of marketing of 3S FINANCIAL GROUP Sp z o.o. ' own products or services on the basis of legitimate legal interest, will be processed until an objection is lodged by the data subject;

3) personal data processed on the basis of a separate consent will be stored until its revocation.

### **User permissions**

The rights of the person to whom the personal data relates:

1) the right to access your personal data, i.e. the right to obtain confirmation whether the Administrator processes data and information regarding such processing;

2) the right to rectify data if the data processed is incorrect or incomplete;

3) the right to request deletion of data, restrictions on data processing;

4) the right to object to data processing on the basis of the Administrator's legitimate interest or to processing for direct marketing;

5) the right to lodge a complaint to the Polish supervisory body or supervisory body of another Member State of the European Union, competent for the place of habitual residence or work of the data subject or for the place of alleged violation of the GDPR;

6) the right to withdraw consent at any time (without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal).

The rights listed above can be exercised by contacting the Administrator, listed in the section "Contact regarding personal data".

### **Data collected automatically**

During a visit to the website, data on the User are automatically recorded, among others IP address, browser type, operating system type. These data are used only for administrative and statistical purposes.

### **Cookies**

The administrator uses Cookies technology. Cookies are packets of information saved on the User's device via the Website, usually containing information consistent with the purpose of the file, with which the User uses the Website.

The administrator uses two types of Cookies:

a. session Cookies - contain information that is stored in a temporary memory location of the User's device and then subsequently deleted after the session is completed or the web browser is closed. This cookie stores information that the user has inputted and tracks the movements of the user within the website. Stored information is then permanently deleted from the device's memory

b. permanent Cookies are stored on the User's hard drive in their device until the user deletes them. They remain stored though the browses is closed or the devide is turned off.

The mechanism of both session Cookies and permanent Cookies does not allow to download any personal data or any confidential information from the User's device. Hence it is not possible to determine the User's identity.

The User may independently change the settings for Cookies at any time, specifying the conditions for their storage, through the settings of the web browser or by configuring the service in accordance with the manufacturer's instructions, but this may cause unavailability of part or all of the Website's functions.

The service provider uses cookies, among other things, in order to authenticate the User on the Website, maintain sessions, adjust the content of the pages to the User's preferences and create (anonymous) statistics that optimize the usability of the Website, through analytical tools such as Google Analytics, analysis and audience research, as well as the provision of advertising services.

### **Social media**

The administrator processes personal data of Users visiting profiles maintained in social media (Facebook, YouTube, Instagram, Twitter). These data are processed only in connection with maintaining the profile, including in order to inform Users about the Administrator's activity and to promote various types of events, services and products, as well as to communicate with Users through the functionalities available in social media. The legal basis for the processing of personal data by the Administrator for this purpose is his legitimate interest (art.6 par.1 lit.f RODO) consisting in promoting his own brand and building and maintaining the brand-related community.

### **Data recipients**

In connection with the provision of services, personal data will be disclosed to external entities, including in particular suppliers responsible for operating IT systems, entities such as banks and payment operators, entities providing accounting, legal, auditing, consulting services, couriers (in connection with the implementation of the order) , marketing agencies (in the field of marketing services) and Trusted Partners.

If the User's consent is obtained, his data may also be made available to other entities for their own purposes, including marketing purposes.

The Administrator reserves the right to disclose selected information about the User to competent authorities or third parties who submit a request for such information, based on an appropriate legal basis and in accordance with applicable law.

### **Trusted Partners**

Customers' personal data are processed by Trusted Partners for marketing purposes, which include necessary analytical activities and compilation into marketing profiles based on activity on the Website. ### **Transfer of data outside the European Union**

Due to the fact that the Administrator uses the services of other suppliers, personal data may be transferred outside of the European Union. In this case, the transfer of data will take place on the basis of an appropriate agreement between the Administrator and this entity, containing standard data protection clauses adopted by the European Commission.
